

# Migration Migration Watch, end of year 2019



- In 2019, there are 272 million migrants worldwide, up 23% from 2010. Mexico has the second largest number of migrants of any country in the world.
- In 2019, there are 12.4 million Mexican migrants in the United States, 5.9 million of whom are women (48%) and 6.4 million of whom are men (52%).
- Remittances to Mexico will have exceeded USD 36 billion by the close of 2019, taking it above the Philippines as the world's third largest recipient of such resources.

**International Migrants Day has been celebrated every December 18** since 2000, when the United Nations General Assembly issued a resolution in response to the high and growing number of migrants around the world.

According to UN estimates, there were approximately 272 million international migrants in 2019, equivalent to around 3.5% of the global population. This number is 9.2% greater than that recorded in 2015, and up 23% from 2010. Many of these migrants are coming from developing regions and traveling to the United States and high-income European countries.

The top five sending countries of migrants are, in this order: India, Mexico, China, Russia and Syria. Meanwhile, the top recipient countries of migrants are: The United States, Germany, Saudi Arabia, Russia and the United Kingdom.




## There are 12.4 million Mexican migrants in the United States in 2019

Two months ago, the U.S. Census Bureau published the results of the Current Population Survey Annual Social and Economic Supplement (CPS ASEC) for 2019. This data allows us to estimate the size and sociodemographic and employment characteristics of the Mexican migrant population living in the United States.


It is estimated that around 12.4 million Mexican migrants are living in the United States in 2019, which is slightly more than in previous years. Although confidence intervals had to be analyzed, the point estimation for 2019 is the highest ever recorded, meaning the number of Mexican migrants is expected to reach record levels.

Of the total number of Mexican migrants, approximately 5.9 million are women (48%) and 6.4 million are men (52%). Most of these migrants—around 9.7 million—are from the most productive age groups, between the ages of 20 and 59.






#### Figure 4. **Mexican migrants residing in the United States by age group, 2019** (Millions)


Mexican migrants in the United States are mainly concentrated in two states, California and Texas, which have 4.2 million and 2.7 million migrants, respectively. They are followed by Illinois and Arizona, which each have 0.7 million migrants.

## Remittances to Mexico will exceed USD 36 billion in 2019

The favorable economic situation in the United States in recent years has allowed Mexicans living in the country to send more remittances back to Mexico. The latest figures from the Bank of Mexico indicate that, by the close of 2019, these remittances will have amounted to nearly USD 36.2 billion, reaching an all-time high once again. As such, Mexico is replacing the Philippines as the world's third largest recipient of such resources.
