Market Comment | Gloomy mood in bond markets on rumours of possible ECB tapering

- Rumours that the ECB might scale back (by €10bn a month) the asset purchases programme remained, pushing European sovereign yields up slightly. Although most analysts had been expecting a temporary extension of the programme or some fine tuning, the effect on financial markets was moderate. However, the hawkish tone from Chicago Fed president Charles Evans also contributed to the increase in sovereign yields registered today, while mixed economic data published in the US failed to shed any light on the Fed's monetary policy path (the ISM non-manufacturing index was better than expected, while ADP non-farm employment changes missed expectations) ahead of Friday's payroll data. All in all, bond markets decreased today across the board, with yields slightly increasing in safe haven bonds (10YUS +4 bps, 10YGER +5 bps), while peripherals showed greater changes (10YITA +6 bps, 10YSPA +6 bps, 10YPOR +7 bps). EM bond yields also increased in the same magnitude.
- The increase in yields across the board weighed on the European equity markets, although the positive trend in oil prices supported fresh gains in energy stocks (Euro Stoxx50 -0.1%, Ibex35 +0.1%, Dax -0.3%). The insurance and banking sectors were among the best performers today, as rumours about the ECB's tapering allayed fears of interest rates going deeper into negative territory which have been weighing on the profitability of these two sectors. Moreover, to judge from market behaviour, concerns about Deutsche Bank (+2.8%) seem to be fading. On the other hand, the worst performing sectors were those affected by higher interest rates (utilities, telecoms and real estate). In the US, stock prices inched up (S&P500 +0.5%), while in Asia the increases were moderate (Nikkei +0.5%, Hang Seng +0.42%), with China's markets closed this week for National Day Festivals.
- In FX markets the euro was broadly unchanged, despite the surprising information on the ECB's potential tapering. The GBP remained at its lowest level since 2011 against the EUR and since 1985 against the USD, as concerns over a "hard" Brexit lingered. Oil prices (+1.9%) were the main supporting factors for market sentiment, showing a steady rise since the OPEC preliminary deal, reflecting reduced concerns over oil glut. The bigger-than-expected decrease in US crude oil inventories published today also boosted oil prices. Meanwhile, EM currencies showed mixed performances (PLN +0.1%, MXN +0.4%, CLP -0.3%).
