

Market Comment | Markets steady ahead of FOMC minutes

- Financial markets were little changed, as there were no significant events. Moreover, investors showed cautiousness ahead of the publication of the **latest FOMC meeting minutes this afternoon**, in which the Fed signalled a faster pace of monetary policy tightening. The major market sensitive developments were the following:
- **The EUR appreciated against the USD**, on the back of higher-than-expected euro zone final composite PMI (54.4 vs. consensus 53.9) for December. In addition, December **inflation in the euro zone was higher than expected** (1.1% vs. consensus 1%), mainly explained by increasing energy prices ([see](#)).
- The Chinese yuan strengthened as China's authorities stepped into markets to shore up the currency, setting a stronger-than-expected daily trading midpoint. Also, China's authorities are studying plans to support the yuan and curb outflows ([see](#)).
- **The MXN depreciated significantly for the second day in a row**, after car companies announced plans to relocate their industrial activities to the USA, following criticism by US president-elect Donald Trump ([see](#)).
